Privacy Notice

1. Introduction

At Taunton Youth Football Club we take your privacy very seriously.

This Privacy Notice sets out how we use and look after the personal information we collect from you. We are the data controller, responsible for the processing of any personal data you give us. We take reasonable care to keep your information secure and to prevent any unauthorised access to or use of it.

2. What personal data we hold on you

Personal data means any information about an individual from which that individual can be identified. We collect, use, store and transfer some personal data relating to our players (and their parents or guardians], and other Club members.

You provide information about yourself when you register with the Club, and by filling in forms at an event or online, or by corresponding with us by phone, email or otherwise.

The information you give us may include your name, date of birth, address, email address, phone number, gender, and the contact details of a third party in the case of an emergency. We may also ask for relevant health information which is classed as special category personal data, for the purposes of your health, wellbeing, welfare and safeguarding. Where we hold this data it will be with the explicit consent of the participant or, if applicable, the participant's parent or guardian.

Where we need to collect personal data to fulfil Club responsibilities and you do not provide that data, we may not be able to honour or administer your membership.

3. Why we need your personal data

We will only use personal data for any purpose for which it has been specifically provided.

The reason we need participants' and members' personal data is to be able to run the Club and arrange matches, to administer memberships, and provide the membership services you are signing up for when you register with the Club. Our lawful basis for processing your personal data is that we have a contractual obligation to you as a participant or member to provide the services you are registering for.

We have set out below, in table format, a description of all the ways we plan to use your personal data, and which of the legal bases we rely on to do so. We have also identified what our legitimate interests are where appropriate.

Sharing data with leagues we are in membership of, county associations and other competition providers for entry in events	Performance of club business
Sharing data with Trustees/committee members to provide information about Club activities, membership renewals or invitations to social events	The Club has a legitimate interest to maintain member and participant correspondence for club community purposes.
Sharing data with third party service or facility providers	The Club has a legitimate interest to run the organisation efficiently and as it sees fit. Provision of some third party services is for the benefit of the Club, participants and its members.
Sharing anonymised data with a funding partner as a condition of grant funding, e.g. Local Authority	The Club has a legitimate interest to run the organisation efficiently and as it sees fit. Application for funding is a purpose that benefits the Club, participants and its members
Publishing match and league results	Consent. We will only publish your personal data in a public domain, including images and names, if you have given your consent for us to do so.
Sending out marketing information such as newsletters and information about promotions and offers from sponsors	Consent. We will only send you direct marketing if you have not previously objected to this marketing, or, you have actively provided your consent.
To ensure we understand possible health risks	Consent. We will only process details on player medical history with your consent. However, failure to provide details of player medical history could be a potential risk to the player and refusal will mean that we will be unable to have a player participate in physical activities.

4. Who we share your personal data with

When you become a member of the Club (whether as a player, parent/guardian, coach or volunteer) may be entered onto the Whole Game System database, which is administered by the Football Association (FA). We also pass your information to the County FA and to leagues to register participants and teams for matches, tournaments or other events, and for affiliation purposes.

We may share your personal data with selected third parties, suppliers and sub-contractors such as referees, coaches or match organisers. Third party service providers will only process your personal data for specified purposes and in accordance with our instructions.

We may disclose your personal information to third parties to comply with a legal obligation; or to protect the rights, property, or safety of our participants, members or affiliates, or others.

Third party Providers

Mailchimp

MailChimp is an online marketing platform operated by The Rocket Science Group LLC, a company headquartered in the State of Georgia in the United States. The Services enables us to mail out club information, and at the same time get real-time data analytics so we are aware if mail is being delivered and opened by club members.

The Mailchimp database holds the player name, parent name email address and age group. You can unsubscribe from the service, however information relating to Taunton Town Youth activities will then only be available through going to the web site, or through Teamer (if applicable).

Teamer

Teamer.net is a sport team management site which makes it easy for sports team organisers to communicate with their team members. We use Teamer to inform you of training times, match times and special events. Rather than age group managers wasting time phoning or emailing parents, one action sends a request of confirmation of attendance to a fixture. A response can be via text, online through a browser or, if you have a smart phone, via the Teamer app. The Teamer app is by far the best way of managing notifications and can be downloaded from teamer.net/apps. The Teamer privacy policy is available at teamer.net/privacy.

The Club's data processing may require your personal data to be transferred outside of the UK. Where the Club does transfer your personal data overseas it is with the sufficient appropriate safeguards in place to ensure the security of that personal data.

5. Protection of your personal data

We have put in place appropriate security measures to prevent your personal data from being accidentally lost, used or accessed in an unauthorised way, altered or disclosed.

6. How long we hold your personal data

We keep personal data on our participants and members while they continue to be a participant or member or are otherwise actively involved with the Club. We will delete this data one month after a participant or member has left or otherwise ended their membership or affiliation, or sooner if specifically requested and we are able to do so.

We may need to retain some personal data for longer for legal or regulatory purposes. The personal data that is stored on Whole Game System is subject to their privacy policy, so we advise you to review that policy together with this notice. If you would like your personal data to be removed from the Whole Game System then please contact them.

7. Your rights regarding your personal data

As a data subject you may have the right at any time to request access to, rectification or erasure of your personal data; to restrict or object to certain kinds of processing of your personal data, including direct marketing; to the portability of your personal data and to complain to the UK's data protection supervisory authority, the Information Commissioner's Office about the processing of your personal data.

As a data subject you are not obliged to share your personal data with the Club. If you choose not to share your personal data with us we may not be able to register or administer your membership.

We may update this Privacy Notice from time to time and will inform you of any changes to how we handle your personal data.
